I am writing to express my full support for the Town of Leland's project-Basin Street Extension. The project will extend Basin Street from Old Fayetteville Road to Village Road and align perfectly with the goals and priorities outlined by the Department of Transportation, particularly in terms of safety, equity, and regional impact.

The extension of Basin Street will serve as a crucial link between key areas within our community. The proposed extension will facilitate smoother traffic flow and enhance accessibility, especially for students and faculty accessing North Brunswick High School. Additionally, it aligns with future development plans for the high school and surrounding areas, promoting economic growth and community development.

The Basin Street Extension Project will be completed in the Town of Leland, located in Brunswick County, North Carolina. This area is in Census Tract 201.04, a historically disadvantaged community. This is a 9 square mile area with a population of approximately 5,800. The median household income is approximately \$44,000, which is 23% lower than the median household income for the state of North Carolina, \$57,000. 18% of households are below the poverty line, which is higher than the state of North Carolina's rate of 14%. This area is also historically categorized as low income, as household income is less than or equal to twice the federal poverty level. This Census Tract is ranked in the 79th percentile for low income. The median home value is approximately \$140,000, which is 26% lower than the median home value for the state of North Carolina, \$190,000. The ethnicity make-up in the Census Tract is 37% White, 42% Black or African American, 13% Hispanic or Latino, 3% American Indian and Alaska Native, 7% other, and 3% two or more races.

The Town of Leland is striving to modernize infrastructure assets to meet the needs of all roadway users. To meet the needs of residents throughout Town, Leland is dedicated to improving roads in a historically disadvantaged community to bring safe and equitable modes of transportation and connectivity to this population.

Furthermore, the planning, preparation, and design activities outlined in the proposal, including an environmental analysis, a feasibility study, and a cost-benefit analysis, demonstrate a thorough and comprehensive approach to project implementation. These pre-construction activities are essential for ensuring the success and sustainability of the project in the long term.
