Dear Representative Rouzer,

Thank you for your consideration of the Sampson Community College (SCC) Foundation request of \$1.5 million for a Community Funding Project (CFP) for an addition to the existing Activity Center that will add 10,000 sf of flexible, multi-purpose space for public safety and occupational training, physical education and wellness programming, and college and community meetings.

The addition has been designed and was approved for bid in 2018, but as a major capital project, the design will require another State Construction Office (SCO) review for compliance with current building code and any other provisions adopted by SCO since the previous review. Once awarded and approved, Sampson Community College will bid the project under a twelve-month construction contract as directed by the SCO.

The SCC Foundation, a 501©3 established in 1986, currently holds nearly \$5 million in assets and is the fundraising arm of the college. Over the past five years, the Foundation has received and processed over \$2 million in program and capital improvement grants on behalf of the college. The nonprofit was also awarded a \$1 million Golden LEAF award last year for a skilled trades project. If awarded the CFP funding, the Foundation, governed by a twenty-seven person board of directors, and working cooperatively with the college Board of Trustees, has the capacity to ensure completion of construction of the Activity Center addition. SCC was allocated \$1.3 million in FY22, \$1.3 million in FY23, and anticipates an additional \$1.3 in FY24 from the State Capital Infrastructure Fund (SCIF). The SCIF funds are reserved and committed to the completion of the project.
